It is further understood and agreed that this waiver, release, and assumption of risk is to be binding on my executors, heirs and assigns. This waiver and release of liability includes, without limitation, injuries which may occur as a result of (a) use of any exercise equipment or facilities which may malfunction or break; (b) our improper maintenance of any exercise equipment or facilities, (c) our negligent instruction or supervision, and (d) slipping and falling while on the premises. **I acknowledge that I have carefully read this waiver and release and fully understand that it is a release of liability. I am waiving any right that you may have to bring a legal action to assert a claim against us for our negligence.**
