Notice is hereby given that on Wednesday, August 23, 2023 at 2:30:00 PM August 30, 2023 at 2:00PM at 130 Avram Avenue, Rohnert Park, California, the City of Rohnert Park will receive and open sealed bids for the Citywide Traffic Signal Safety Improvements Project No. 2022-25. Sealed bids shall be dropped off in the secured box to the right of the main doors in front of City Hall before 2:30:00 PM 2:00PM on Wednesday, August 23 August 30, 2023. The work is described generally as traffic signal hardware upgrades at locations citywide. The Contractor must have a valid California contractor's license, a Class A or C-10 license. The Engineer's estimate for this project is \$1,337,000. The Contractor must begin work within fifteen (15) calendar days after official notice by the City Engineer to proceed with the work and must diligently prosecute the same to completion within 180 calendar days of that Notice.

Page 1-3, Second Paragraph, update as follows:

PART 4 - Technical Specifications

Page 4-2, Item 3 Update as follows:

Remove and Become Property of Contractor existing Traffic Signal Backplates and replace with Install Yellow retroreflective border to backplates: Includes cost of materials, equipment, labor to install retroreflective border to remove existing traffic signal backplate from existing traffic signal head mounted on signal mast arm or signal pole and furnish and install a new yellow retroreflective border backplate (3 section, 4 section, or 5 section, as noted on the plans) on existing or new 12" traffic signal heads as shown on the plans."
