8.2 SITE PLAN & ARCHITECTURAL REVIEW – File No. PLSR16-0003 – Anthony Caltaldo/Ware Malcomb – Consideration of Resolution 2017-11, approving Site Plan and Architectural Review for a 10,000 square foot office/industrial building, KG Technologies, located on State Farm Drive (APN 143-021-079)

Ceqa: In accordance with the California Environmental Quality Act (CEQA), an EIR was prepared for the Priority Development Area Plan (PDA). The KG Technologies project is located within the PDA, an analysis was prepared to evaluate the consistency of the proposed project with the PDA EIR. As demonstrated in the analysis, the proposed KG Technologies project is consistent with the PDA Plan analyzed in the PDA EIR.

8.3 PUBLIC HEARING – CONDITIONAL USE PERMIT – File No. PLUP17-0002 - James Mahon, Grizzly Malt, LLC – Consideration of Resolution 2017-14, approving a Conditional Use Permit for agricultural processing located at 5500 Commerce Boulevard (APN 143-021-044)
