

ORDINANCE NO. 802

**AN ORDINANCE OF THE CITY COUNCIL
OF THE CITY OF ROHNERT PARK
AMENDING SECTION 10.20.010 OF THE
ROHNERT PARK MUNICIPAL CODE
DECLARING PRIMA FACIE SPEED LIMITS**

The City Council of the City of Rohnert Park does ordain as follows:

SECTION 1. Section 10.20.010 of the Rohnert Park Municipal Code is hereby amended as follows:

By adding thereto:

“Rohnert Park Expressway from Commerce to State Farm	35 M.P.H.
Rohnert Park Expressway from State Farm to Country Club Dr	40 M.P.H.
Rohnert Park Expressway from Country Club Dr to Snyder	45 M.P.H.”

By deleting:

“Rohnert Park Exwy. from Snyder to Jasmine Cir.	40 M.P.H.
Rohnert Park Expressway lying east of Commerce Boulevard	35 M.P.H.”

By modifying:

“Rohnert Park Expressway lying west of Redwood Drive	40 M.P.H.”

SECTION 2. All other speed limits listed in the Municipal Code, not modified by this ordinance shall remain in full force and effect.

SECTION 3. Repeal of Conflicting Ordinances. All former Ordinances or parts thereof conflicting or inconsistent with the provisions of this Ordinance or of the Code hereby adopted are thereby repealed.

SECTION 4. Severability. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it should have adopted the Ordinance and each section, subsection, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections subsections, sentences, clauses or phrases be declared unconstitutional.

SECTION 5. Effective Date. This Ordinance shall be in full force and effective thirty (30) days after its adoption and shall be published and posted as required by law.

This ordinance was introduced on the 12th day of August 2008 and **DULY AND REGULARLY ADOPTED** by the City Council of the City of Rohnert Park this 26th day of August, 2008 by the following vote:
